# Why is NCIDQ Certification Important?

- Industry Standard
- Differentiator

- NCIQ
- Recognized by nearly all regulated jurisdictions in North America
- Increased Salary Potential
  - NCIDQ certification makes a difference. Median salary is \$16k higher compared to those not currently holding any type of certifications and credentials.

• Those with an NCIDQ certification reported a median salary \$10,000 greater than those without (\$70,000 versus \$60,000).

## Exam Basics

## The NCIDQ Exam consists of 3 separate sections:

Exam Name	Format	Number of Questions	Duration
Fundamentals (IDFX)	Multiple Choice	125*	3 hours
Professional (IDPX)	Multiple Choice	175*	4 hours
Practicum (PRAC)	Hot Spot, Drag and Place, Fill in the Blank	120*	4 hours


\*The IDFX and IDPX Exams each contain 25 ungraded pre-test questions. The PRAC Exam contains 15 ungraded pre-test questions, 5 per case

study.

## Practicum Exam

- No drawing
- Not software specific
- 120 total questions
- 4 hours in duration

# Eligibility Paths

#### **Education**


Official education transcripts must include a minimum of 60 semester or 90 quarter credit hours of post-secondary interior design coursework that encompasses a certificate, degree, or diploma from an accredited institution to be eligible.

# Experience Hours must be earned and affirmed by a Direct Supervisor and/or Sponsor\*

• Up to 1,760 hours of interior design work experience, earned prior to graduation, may be included in overall work experience total.

#### **Education**

**Official education transcripts must include a minimum of 60 semester or 90 quarter credit hours** of post-secondary interior design coursework that encompasses a certificate, degree, or diploma from an accredited institution to be eligible.



+ Experience Hours must be earned and affirmed by a Direct Supervisor and/or Sponsor\*

Up to 1,760 hours of interior design work experience, earned prior to graduation, may be included in overall work experience total.



Meeting CIDQ's education and work experience requirements does not guarantee that a candidate will meet their jurisdiction's requirements to be a licensed/registered/certified interior designer. Individuals are reminded to check with their jurisdiction regarding those specific requirements.

## Application Requirements

#### **IDFX ONLY**

- Request school to email official transcript(s) to CIDQ directly at <a href="mailto:transcripts@cidq.org">transcripts@cidq.org</a> (preferred method) or mail in sealed, official transcript(s).
- Pay application fee and submit.

## PLUS apply for IDPX/PRAC (after approval of IDFX ONLY and completion of work experience)

- Request school to email official transcript(s) to CIDQ directly at <a href="mailto:transcripts@cidq.org">transcripts@cidq.org</a> (preferred method) or mail in sealed, official transcript(s).
- Upload completed work verification form(s).
- Pay application fee and submit.

#### OR

## All Three (3) Sections of Exam (IDFX, IDPX, PRAC)

- Request school to email official transcript(s) to CIDQ directly at <a href="mailto:transcripts@cidq.org">transcripts@cidq.org</a> (preferred method) or mail in sealed, official transcript(s).
- Upload completed work verification form(s).
- Pay application fee and submit.

With the shift to the use of the International Building Code (IBC)(2018) for the Spring 2021 Exam Administration, CIDQ would like to provide additional information which may be helpful to candidates in understanding the changes specifically related to the Practicum exam.
